UPMC Dental *Advantage* Discount Dental Plan

- Effective January 1, 2016, UPMC Dental *Advantage* will offer a Discount Dental Plan to new and current employer groups as either a standalone plan option or along with the Basic plan offering.
- Employees who choose to enroll in the standalone Discount Dental Plan will receive a 20 percent discount on eligible Class I, II, and III services.
- Members enrolled in a UPMC Dental *Advantage* Basic dental plan are eligible for a 20 percent discount on eligible Class II and Class III services when received by a participating dentist.
- Members must receive services from a UPMC Dental *Advantage* participating dentist in order to be eligible for the 20 percent discount.
- The discount does not apply to orthodontic or cosmetic services.
- The 20 percent discount is applied to the provider's usual and customary charge.
- Members should refer to the UPMC Dental *Advantage* employer-specific plan documents for a list of discounted services by:
 - Visiting **www.upmchealthplan.com**.
 - Logging in to *MyHealth OnLine*.
 - Selecting the Coverage and Benefits tab
 - Selecting Your Benefits.
 - Clicking on Dental Coverage.
- The UPMC Dental *Advantage* Discount Dental Plan may not be used in conjunction with other insurance.
- To find a UPMC Dental *Advantage* participating dentist or to see if a specific dentist participates in our discount plan network, your employees should visit **www.upmchealthplan.com**, click the Doctor icon at the top of the page, and select Dental.

Using the UPMC Dental Advantage Discount Dental Plan

To receive discounted services from a UPMC Dental Advantage dentist, your employees should:

- Contact their dentist to schedule an appointment.
- Notify the dentist that they are a UPMC Dental Advantage Discount Dental Plan member.
- Provide the office with the subscriber's demographic information and the name of the member receiving care.

Remember! Claims do not need to be submitted for services purchased with the discount plan, and UPMC FlexAdvantage members can use their card to pay for eligible dental services.

The provider will verify eligibility for discounted services. ID cards are not required for treatment. However, ID cards can be downloaded from MyHealth OnLine at www.upmchealthplan.com.
