UnitedHealthcare

Machine-readable files required on public websites by **July 1, 2022**, for Transparency in Coverage:

- The government requirement applies to plan years beginning **on or after Jan. 1, 2022**.
- Include detailed pricing data for all covered items and services via 3 MRFs:
 - In-network negotiated payment rates
 - Historical out-of-network allowed amounts
 - In-network rates and historical costs for prescription drugs (delayed pending guidance)
